### The Accident



According to eyewitnesses, Aguilera-Mederos' truck was travelling at a high rate of speed when it collided with a line of stopped cars at the bottom of a hill on the I-70 highway. The truck caused a chain reaction of collisions that involved a total of 28 vehicles and resulted in four deaths and multiple injuries.



In the aftermath of the accident, Aguilera-Mederos told investigators that he had lost control of the truck's brakes and was unable to stop in time to avoid the collision. However, investigators later determined that the brakes on the truck were functioning properly and that the cause of the accident was likely driver error.

- Legal Proceedings

- Aguilera-Mederos was charged with 40 criminal counts, including four counts of vehicular homicide. He pleaded not guilty to all charges and was released on bond pending trial.

- In September 2021, after a four-week trial, a jury found Aguilera-Mederos guilty on all counts. He faces up to 110 years in prison when he is sentenced in December.
